Join us at the Y this summer full of wonder, discovery, and joyful learning!



AFTERNOON ADVENTURES!	THEMED FUN 12:30 PM – 2:45 PM	Campers rotate between outdoor play, gym time, classroom activities, and art in the cafeteria. Themes keep children active, excited, and learning through play.

Please send your camper with a swimsuit and towel every Friday.

Campers will be bussed to the Sewickley Valley YMCA each Friday to swim in the warm water pool for 30 minutes between 10 AM and 12 PM.

ENROLLMENT AND PAYMENT

Enrollment forms must be completed online on the Friday prior to your child's first day of camp. All registrations must occur three days before the start of the session(s) your child wants to attend. The full fee is required for the first session of camp enrolled. All children must be potty trained to attend camp.

Multiple session registrations require the full fee for the first session and a \$25 non-refundable deposit for each subsequent session(s). All balances owed after the first session that have not been paid in full must be paid by the dates listed.

Late Enrollment and Cancellation Policy

The dates listed in the above are the last opportunity for a participant to cancel an existing preschool camp registration, or, register without a \$25 late registration fee. If cancellation of a camp occurs on the dates listed, all non-refundable deposits will be forfeited. After the dates listed, payment must be paid in full regardless of the participant's attendance. Refunds

Drop-Off & Authorization for Pick-Up

You may drop off your camper no earlier than 8:55 a.m. There must be a counselor present when your child is dropped off. Everyone who picks up a child from the summer day camp must be on the authorization list provided by the parent(s)/guardian. Anyone not on the authorization list will not be permitted to pick up a child. Parents, please remember to add yourself to the authorization list.



Photo Identification

A photo I.D. must be shown by anyone who will be picking up children from the YMCA. Anyone who does not have a photo I.D. will not be allowed to pick up a child. Thank you for your cooperation in helping to keep our children safe. All individuals on your authorization list must be 16 years or older and have a valid photo I.D.



Late Pick Up

If a parent/guardian will be late for pick up, please call (412) 660-4147. The camper may be removed from the camp program if late pick ups occur. Please respect pick up times for staff/safety concerns. Any parent picking up after 3:00 PM is considered late and will be charged the late fee of \$1 per minute.

Refrigeration is unavailable.




SUMMER CAMP GEAR

Bring a backpack or shoulder bag to carry daily essentials: a swimsuit, towel, and sunscreen.



Personal items not part of the program are not allowed, including:

- **Valuables**, electronics, and cell phones
- **Solution** Toys, games, and tradeable items (e.g., cards or collectibles)
- **Books** or other personal items
- Sandals, flip-flops, or open-toed footwear

CAMPER SAFETY

The YMCA's first responsibility is the safety of every child. The following is vital information about safety, behavior, health, and camp policies. Please read and review it with your family before the start of camp.

Aids and Therapeutic Support

All campers who require an Aid or Therapeutic Support Staff (TSS) during the school day must have the TSS or Aid in Preschool Camp. All parties must speak with the Child Care Director (412) 741–9622 ext. 133 two weeks prior to the beginning date of camp with completed forms (Act 33 & 34 clearances, FBI Background and National Sex Offenders Registry clearance, and the company's liability insurance). Please remember the TSS or aid must accompany the child for the entire session.

Aquatic Safety

Fun is part of the YMCA, but so is safety. Where there are YMCA day campers and pools, there are YMCA lifeguards and counselors. Lifeguards are on the pool deck, and camp staff swim, splash, and play games with the campers.

YMCA pools are staffed with lifeguards who meet national lifeguard certification standards, participate in regular in-service training, and are audited regularly to ensure they are always rescue-ready and responsive. Camp staff camper ratio is 1:5. All students will be placed in a swim trainer, water back float, or lifejacket, regardless of swim level and ability.

Authorized Pick Up

Only individuals listed as Authorized Pick Up may pick up a child. A valid photo ID is required for pick up. Anyone without a photo ID will not be allowed to pick up a child.

Behavior

Basic rules include respecting each other, the property of others, the YMCA facility, the child's safety, and the group's security.

Behavior management is accomplished through a positive approach and redirection, which will respect the child as an individual. Discipline procedures are handled individually, with a mild consequence associated with the particular infraction.

No child will ever be subjected to verbal abuse, ridicule, humiliation, or denial of basic needs such as food, rest, or bathroom access. There is no punishment for toileting accidents or food-related behaviors.

There is no punishment for soiling, wetting or not using the toilet, and no punishment related to eating or not eating food.

ABUSE PREVENTION AND REPORTING

The Sewickley Valley YMCA has a zero-tolerance policy for abuse and complies with Pennsylvania state law. This requires the reporting of suspected child abuse or imminent risk, including both adult-to-child and peer-to-peer abuse. Staff and volunteers are trained in abuse prevention and reporting procedures.

Health and Wellness

Medical Considerations:

List any allergies or medical needs in your camper's online account profile. Keep the profile up-to-date, and keep your counselor informed.

Medications must be sent in their original prescription bottles, with only the daily dosage included.

Illness:

Children showing signs of illness (e.g., fever, rash, diarrhea) must be picked up by an authorized pick up person listed on the child's account profile.

Injuries:

YMCA camp staff will administer first aid if a child is mildly injured during the daily activities.

If the injury requires outside medical attention, the child will be taken to the emergency room by ambulance and accompanied by the Child Care Director or Head Counselor. The parent will be called and should meet the child at the emergency room.

An incident report will be completed for all injuries for the YMCA records.

Safe Release

An impaired condition specifically related to alcohol, mind-altering chemicals or other medical conditions that render a person unable to operate a motor vehicle and thereby endanger the safety of a child who would be transported by the impaired person.

If in the judgment of the responsible personnel at the Preschool Camp, a parent or designated person appears to be unable to transport a child safely, the camp personnel will ask the parent or designated person to arrange such transportation. If the person is unwilling to provide such alternate transportation, the matter will be referred to the police before the child is released for transportation. Hopefully, the necessity to implement this policy will not arise, but should it, the parent/the designated person must be apprised of the policy.

Termination and Suspension

The Sewickley Valley YMCA reserves the right to suspend or terminate camp services with a one-day notice. In cases where a child's behavior poses a safety risk to themselves, staff, or others, services may be terminated immediately. Camp services may also be immediately terminated due to overdue fees or inappropriate parent/guardian behavior, as determined by the Child Care Director.
